****Privacy Policy****

The My Workout Group app is a Free app. This SERVICE is provided at no cost and is intended for use as is. My Workout Group is located in Austin, Texas, 78712.

This page is used to inform visitors regarding my policies with the collection, use, and disclosure of Personal Information if anyone decided to use my Service.

If you choose to use my Service, then you agree to the collection and use of information in relation to this policy. The Personal Information that I collect is used for providing and improving the Service. I will not use or share your information with anyone except as described in this Privacy Policy.

The terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, which is accessible at My Workout Group unless otherwise defined in this Privacy Policy.

****Definitions****

For the purposes of this Privacy Policy:

Account means a unique account created for You to access our Service or parts of our Service.

Affiliate means an entity that controls, is controlled by or is under common control with a party, which means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.

Application Means the software program provided by the Company downloaded by You on any electronic device, named My Workout Group

Company refers to My Workout Group.

Country refers to: Texas, United States

Device means any device that can access the Service such as a computer, a cell phone or a digital tablet.

Personal Data is any information that relates to an identified or identifiable individual.

Service refers to the Application.

Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.

Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

You means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

****Information Collection and Use****

For a better experience, while using our Service, I may require you to provide us with certain personally identifiable information, including but not limited to name, email, gender, age. The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

The company also complies with the following GDPR statements:

1. Lawfulness, fairness, and transparency: obey the law; only process personal data in a way that people would reasonably expect; always be open about your data protection practices.
2. Purpose limitation: you must normally only process personal data for the specific reason you collected it and nothing else.
3. Data minimization: don't process any more data than you need.
4. Accuracy: make sure that any personal data you hold is adequate and accurate.
5. Storage limitation: don't store personal data for longer than you need to.
6. Integrity and confidentiality: always process personal data securely.
